The District and Association hereby agree:

The Subject Area Sub-Committees will engage subject matter experts in discussion focused on the implementation of new state standards in order to guide and support Local Control Accountability Plan (LCAP) goals.

The Subject Area Sub-Committees will:

- Provide input and make recommendations to Curriculum Advisory Committee (CAC) and Common Core Steering Committee (CCSC) on LCAP goals pertaining to curriculum.
- Review and make recommendations to the CAC on subject area curriculum, instructional materials and textbooks.
- Collaborate and share recommendations with District Technology Advisory Committee (DTAC), Benchmark Assessment Steering Committee (BASC), Instructional Professional Development Committee (IPD), and Special Education Steering Committee as needed.
- Review and make recommendations on the implementation of new standards.
- Document and share information with CAC and CCSS and other relevant committees.
- Subject Area Sub-Committees will be comprised of subject matter experts representing grade level spans selected by the Association.
- Subject Area Sub-Committees will be co-chaired by a District representative and CAC representative agreed upon by the elected CAC representatives.
- Subject Area Sub-Committees will determine the frequency of meetings.
- All Subject Area Sub-Committees meetings are open to all members.
- Subject Area Sub-Committee meeting calendar and notes will be posted on the district website and LETA website.

This MOU will be reviewed annually in May and will expire on June 30, 2017.
